Summary

This position performs investigations as necessary to support the prosecution of cases. The investigator will interview witnesses, visit the scene where an incident took place, process and serve subpoenas and conduct investigations that would inform such prosecution. Assist in the process of requesting, reviewing, discovering and preparing all electronic media for the office and trials.

Essential Functions

Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

1. Obtain and review case information to determine appropriate investigative methods to acquire and verify evidence with assigned prosecutors.
2. Investigate cases which shall include interviewing clients, witnesses, professional experts, law enforcement and other personnel as well as gathering evidentiary materials.
3. Reviews evidence for the preparation of trials and prepares professional photographs, diagrams, maps and trial exhibits of this evidence to facilitate improved understanding of a case.
4. Maintain the status of cases and participate in case review meetings with attorneys.
5. Maintain and provide subpoena service in a timely manner to assigned attorney and/or assist in obtaining subpoena services when local service is unavailable.
6. Obtains, analyzes and disseminates pertinent records including court, medical, military, criminal, and psychological; reviews presentence reports, and prepares appropriate support documents.
7. Request, receive and coordinate all incoming electronic media for the office.
8. Review electronic media recordings, both audio and visual, to redact and prepare the evidence for courtroom presentation, disclosure to defense, and Freedom of Information Act (FOIA) requests. These recordings may include but are not limited to body worn camera video, police patrol video, 911 dispatch call audio, and cell phone video or audio.

9. Appear as a witness and testify at trials and hearings.
10. Perform other duties as assigned.

Supervisory Responsibility

This position does not have direct supervisory responsibilities.

Work Environment

This job operates in various indoor and outdoor settings where the employee may need to deal with individuals in various states of intoxication, emotional, and mental conditions; will be required to work outside in all types of weather; exposure to a variety of foul odors; exposure to contact with the bodily fluid of others.

Physical Demands

The physical demands described here are representative of those that must be met by an employee to successfully perform the essential functions of this job.

While performing the duties of this job, the employee is regularly required to express oneself and exchange information both verbally and in writing. The employee is frequently required to move about the work environment on uneven terrain both indoors and outdoors; operate a computer and other machinery; and move or transport files or other items to meetings and other locations. The ability to climb up and down ladders and stairs, crawl in confined spaces, bend, stoop, kneel and the ability to withstand periods of prolonged standing are all required of this position.

Travel

Travel is required 25%-50%.
