BOARD OF COMMISSIONERS - SUPPORT LAKE ALLEGAN ASSOCIATION'S REQUEST TO MEET WITH GOVERNOR WHITMER TO DISCUSS RIVER HYDROELECTRIC POWER

21/ WHEREAS, in a news release dated August 9, 2022, Consumers Energy announced it will "gather opinions from the public about the 13 dams they own and operate on five Michigan rivers to help guide their decisions about the future of those electric generating facilities"; and

WHEREAS, on August 31, 2022, Consumers Energy held a public meeting in Allegan County regarding Calkins Bridge Dam; and

WHEREAS, public members and local leaders expressed great concern regarding the potential removal of the hydro facilities/dams during the

meeting and have further expressed concerns in writing to the Board of Commissioners; and

WHEREAS, the Board of Commissioners believes that Lake Allegan is an integral part of our region, and other dams and lakes are likely an integral part of their respective regions, the dams and lakes should be preserved; and

WHEREAS, to support Lake Allegan and to learn the economic impact of the decommissioning of the 13 potentially-affected dams across our great State of Michigan, it was deemed imperative that we obtain reliable and objective data relative to the operating costs and full economic impact of each dam to the respective community; and

WHEREAS, the Board of Commissioners requested via resolution on October 13, 2022, that the West Michigan Regional Planning Commission take the necessary and immediate measures to secure funding and assistance from the U.S. Economic Development Administration (EDA) and the Michigan Economic Development Corporation (MEDC) to conduct a full economic impact study of each dam (eight of which exist within the West Michigan region) and progress has been made among the parties towards commissioning a study; and

WHEREAS, the Board of Commissioners has identified river hydroelectric power as a reliable, stable source of power for both Allegan County and the State of Michigan; and

WHEREAS, the Lake Allegan Association, and other interested Michiganders, are circulating a letter to request that Governor Whitmer support river hydroelectric power as a critical source of Michigan's electricity and meet to discuss the same.

THEREFORE BE IT RESOLVED, the Board of Commissioners agrees that river hydroelectric power is an essential component in ensuring that the state of Michigan has stable and reliable sources of electricity and supports the Association's request to meet with Governor Whitmer and respectfully urges the Governor to accept the invitation and recommends the Energy Great Lakes and Environment (EGLE) Director be included in said meeting and made available as a contact to the Association regarding this matter.

THEREFORE BE IT FINALLY RESOLVED, the Clerk is hereby instructed to provide a certified copy of this resolution to Governor Whitmer, Lt. Governor Gilchrest, Senators: Thomas Albert, Aric Nesbitt, Roger Victory; Representatives: Joey Andrews, Nancy DeBoer, Matt Hall, Angela Rigas, Pauline Wendzel and Rachelle Smit.

BOARD OF COMMISSIONERS - HONORING MICHIGAN ASSOCIATION OF COUNTIES

22/ WHEREAS, Michigan's 83 county governments play a central role in the proper delivery of, and oversight for, critical public services for the state's approximately 10 million residents; and

WHEREAS, Michigan county governments are led by Boards of Commissioners, who are elected from their communities; and

WHEREAS, the State Association of Supervisors of Michigan was formed by representatives of 16 counties on Feb. 1, 1898, in the Senate chamber of the Michigan State Capitol in Lansing; and

WHEREAS, the association's name was changed to the Michigan Association of Counties on July 17, 1969; and

WHEREAS, the Michigan Association of Counties is the oldest association representing local governments in Michigan; and

WHEREAS, 48 of Michigan's 83 counties have had at least one of their commissioners (or supervisors prior to 1968) serve as president of the association's Board of Directors; and

WHEREAS, the association created the Michigan Counties Workers' Compensation Fund in 1979 to help county members provide workplace safety and injury insurance services to its employees; and

WHEREAS, the association created the Michigan Association of Counties Service Corporation in 1986 to partner with service providers to help counties save money on everything from health insurance to telecommunications services; and

WHEREAS, the association hosts two major conferences every year to bring together county leaders for briefings on trending public policy issues and to hear from state newsmakers and others; and

WHEREAS, the association's advocacy work in Lansing and beyond has advanced the interests of county governments and the residents they serve; and

WHEREAS, no fewer than five association presidents have served or are serving in the Michigan Legislature in the 21st century, a testament to the culture of public service inculcated by the association.

THEREFORE, BE IT RESOLVED that the Allegan County Board of Commissioners wishes to commend and honor the Michigan Association of Counties on its 125th Anniversary year.
