Dear Allegan County Taxpayers-

On behalf of Chief Deputy Clerk Jackie Porter and Chief Deputy Register Amy Nelson as well as the deputy clerks and deputy registers that comprise the best customer service team in West Michigan, it is my pleasure to present to you the 2022 ANNUAL REPORT for the two offices and four divisions under my purview.

The year saw a great many accomplishments in working with our partners throughout Allegan County. The Elections Division worked with local jurisdictions adding three new voting precincts to accommodate the population increases of the 2020 census. This resulted in my office conducting more coordination than ever between local clerks, the Bureau of Elections, and our voters. In that effort, we trained and certified a record 683 election inspectors. The division oversaw 3 elections and one recount during 2022.

While the Vital Records Division saw a slight decline in overall transactions of 381 from 2021's total, the deputy clerks in that office were quite busy with the highest number of homebirths recorded in decades and an increase in applications to become a Notary.

Throughout 2022, the Circuit Court Records area of the Clerk's Office processed 454 applications for Personal Protection Orders. At the same time, the division disbursed \$250,319.73 to victims of crimes.

In the Register of Deeds Office, we were excited to roll out our new *Property Fraud Alert* service. This long awaited service will allow our constituents to receive an alert for free if someone should attempt to commit title theft or property fraud with a land record. The office also saw signs of the previously redhot West Michigan real estate market cooling off as the overall number of land related documents declined for the first time in four years. At the same time, the amount of State Real Estate Transfer Tax collected in 2022 rose from \$7.3 million to \$7.41 million dollars. This number, though a record, represents the smallest increase in real estate transfer tax collected in over a decade.

I hope you find the information in the *ANNUAL REPORT* valuable. While on the surface the document may seem like simply a lot of numbers, those numbers are a testament to the customer service and professionalism of the deputy clerks and deputy registers who serve the taxpayers of Allegan County every day.

OFFICE OF THE COUNTY CLERK

The Clerk's Office is comprised of three divisions: Elections, Vital Records, and Circuit Court records.

ELECTIONS

Over 57,000 Allegan County residents cast ballots during the Gubernatorial Election in November 2022. High turnout and numerous changes to election law pushed the county's Elections Division into constant problem solving mode all year. In particular, the new maps of state house, state senate and congressional districts radically changed the district lines voters had lived with for ten years as a result of Proposal 2 of 2018. The many changes and challenges led the County Clerk's Office to collaborate with local clerks to improve and strengthen training

The Elections Coordinator collaborates with the staff throughout the county office, state agencies, other county clerks (across Michigan and throughout the U.S.), as well as township and city clerks throughout Allegan County. This work covers three basic areas related to elections: maintaining the Qualified Voter File, meeting the Campaign Finance and

educational needs of candidates, and serving the election needs of Allegan County voters.

The Qualified Voter File

The Qualified Voter File (QVF) is a state-run database of every legally registered voter in Michigan. To ensure the integrity of voter rolls for Allegan County residents, the Elections Coordinator facilitates entry of newly registered voters, address updates, and removal of electors who have moved, who request to be removed from rolls or who have passed away. The coordinator also communicates with other states to remove from voter rolls those voters from Allegan County who move across state lines. Maintaining the integrity of the QVF is essential to protecting the security of the vote.

Campaign Finance

Maintaining the many election files that serve Allegan County candidates, residents, and the public at large is a constant effort. The Elections Division makes every effort to align Allegan County filing policies with the everchanging Campaign Finance Law governed by the Bureau of Elections in Lansing.

During 2022, the Clerk's Office oversaw and accepted campaign filings from 86 candidates and 3 ballot initiative groups while accepting candidate filings from "write in" candidates for school board positions as well.

Clerk Genetski congratulates the Honorable Tim Bala on his service. Bala was first elected Mayor of Wayland in 2008 and served through 2022.

ELECTIONS AND THE PUBLIC 2022 Elections

The May 3rd Election

The May 3rd Special Election affected 15 jurisdictions throughout the county. The school districts of Allegan, Delton- Kellogg, Hudsonville and Zeeland had proposals on the ballot while the City of Fennville had a 4 mill public safety initiative. Casco, Fillmore, and Trowbridge Townships ran ballot questions as well. Of eligible voters, 11.84% cast a ballot.

May 3 election: What passed, failed in West Michigan



The Allegan Public Schools Bond Proposals were successful on May 4^{th} , and while the City of Fennville's Public Safety initiative received a majority of votes, it did not earn the percentage needed to pass per the city charter.

The August 2nd State Primary Election

The 24 townships and nine cities in Allegan County were very active in the August Primary. The ballot was long and complex, forcing clerks and election inspectors to put in overtime in preparation to help voters. Electors decided partisan nominees for federal, state, county and local office as well as a county proposal.

Of the eligible 96,166 voters, 30.59% (or 29,417) cast ballots in August.

Voters in Saugatuck Township, the City of Saugatuck & the City of the Village of Douglas saw a renewal on their ballots for the Interurban. Requests from the City of Holland, South Haven, and the townships of: Allegan, Cheshire, Dorr, Ganges, Gun Plain, Hopkins, Laketown, Lee, Martin, Overisel, Valley and Watson were all decided by the electorate on the 2nd. Fennville, Gobles, and Wayland Union public schools had requests as did the Fennville District Library.

The November 8th General Election

There was no shortage of decisions for voters to make on the November ballot.

In addition to deciding the race for governor, the November Election determined Allegan County's new U.S. Congressman-Bill Huizenga (R – Zeeland) in the newly created 4th Congressional District. Partisan nominees also were elected to the three new State Senate seats that represent parts of the county and the six State House seats that the county was carved up into.

Clerk Genetski conducted trainings in all four corners of the county and many points in between. Trainings were offered in the mornings, afternoons, evenings and on weekends to accommodate the all-time record of 683 election inspectors who were certified in 2022.

Five candidates won seats on County Board of Commissioners, and several partial terms for township offices were filled.

On the non-partisan section of the ballot, two Justices were elected to the State Supreme Court on that ballot. Voters chose three judges for seats on the State Court of Appeals and one each for the 48th Circuit Court and for Holland's 58th District Court. Lake Michigan College and Grand Rapids Community College elected members to their Boards of Trustees.

Citizens throughout the county voted for mayor, city council as well as village trustee and village clerk.

Three state proposals were decided as well as local ones for: the townships of Cheshire, Laketown, Otsego (3 renewal requests), Saugatuck (2), and one for the Village of Hopkins and the cities of Fennville & Holland. Voters selected school board members for the districts of Allegan, Bloomingdale, Caledonia, Delton-Kellogg, Fennville, Glenn, Gobles, Hamilton, Holland, Hopkins, Hudsonville, Martin, Otsego, Plainwell, Saugatuck, South Haven, Thornapple-Kellogg, Wayland, and Zeeland.

There were numerous school proposals decided during the General Election while the Allegan District Library Board members were on the ballot as well.

Voters in the Village of Hopkins voted 72% to 27% to revise the Village Charter and elected a commission to oversee that duty as well.

The Statewide Recount in December

Shortly after the results of the General Election were certified by the State Board of Canvassers, an election integrity group successfully filed a petition to recount Proposal questions 2 & 3 in

jurisdictions statewide. The recount included four Allegan County precincts and their Absent Voter Counting Boards.

The State Bureau of Elections requested that Allegan County host the hand count for the Ottawa, Berrien, and Barry County jurisdictions involved as well. In December, the City of Allegan's Griswold Auditorium was packed with clerks, counters (performing the hand count of the ballots), state officials, county boards of

canvassers, election integrity advocates, the media and curiosity seekers.

Local elections teams from Allegan County had a lot to be proud of when the hand count was complete. Over 7,200 ballots were involved, and of all those votes, one additional "yes vote" was added to the totals (as the voter did not fill in the oval dark enough to be read by the tabulator). This result speaks incredibly well of the work our local clerks and inspectors do.

The Vital Records Division

The Vital Records Division assists Allegan County residents with filing and obtaining birth certificates, marriage certificates, death certificates, and genealogy research.

In addition, the division receives applications for Concealed Pistol Licenses (CPL's), the recording of home births, notary public applications, small business licenses (DBA's) and provides the free service of registering papers of honorable military discharge.

Certified copies of certificates can be obtained by visiting our office between 8 AM and 5 PM, Monday through Friday. If someone is unsure of a record, friendly deputy clerks are happy to answer any questions they can over the phone at (269) 673-0450. Division Overview

The hard working deputy clerks recorded 4,686 vital documents throughout 2022 – the third highest number of the last six years. The overall amount of transactions declined by 381 from the year 2021. The biggest reason for the overall decline was a reduction in the number of Concealed Pistol Licenses. Even so, the year saw a record number of Allegan County home births at 42. Notary applications also saw an increase from numbers in 2021 as they grew from 216 to 235.

For the fourteenth year in a row, Concealed Pistol License Applications accounted for more of the transactions in Vital Records than any other- amassing 2,227 in 2022. There were 986 deaths recorded in Allegan County - the highest number on record. Marriage Licenses came in as the 3rd most popular record created at 731. At 446, DBA's registered ranked fourth among all categories in 2022. The office accepted 235 Notary Public applications while there were 42 home births and 19 DD 214's registered.



Concealed Pistol License Applications represented 48% of the total service requests in 2022 with 2,227. The 986 death certificates comprised 21% of all vital records for the year. At 16%, there were 731 marriage licenses filed, followed by the 446 DBA's (small business licenses) or 9% of all transactions. The 235 notary applications, 42 home births and 19 DD 214's recorded served as 5%, 1% and less than 1% of the total respectively.

Trends in Live Home Births

Since 2009, there are no longer any "birthing hospitals" in Allegan County. So, the only birth certificates initiated in the County Clerk's Office are those for "live home births" (except in the case of emergencies). Due to a recent change in the law, fewer and fewer of the county's little cherubs come to Vital Records at the Courthouse with their parents for physical verification. Instead, the midwife performs the verification and files the birth record directly with the state. When the record is generated, one copy is recorded with the county and the other is on file with the Michigan Department of Health and Human Services – State Office of Vital Records.

The 42 births occurring in Allegan County in 2022 is the largest number since 2009.

Laketown, Dorr, Allegan, Watson and Gun Plain Township each had 2 recorded.



Trends in Marriage Licenses



There were 731 couples who found love and got married in Allegan County during 2022. That number was down by 68 from 2021. Since 2009, the single year high of marriage licenses is 850 in 2018 while the low was 655 attained in 2009.

Did you know??? The earliest recorded marriage license in the vault at the County Clerk's Office is for a marriage in the "Michigan Territory."




The marriage of John W. Watson of Allegan to Betsy Ives of Allegan occurred on December 17th, 1835 and was solemnized by Justice of the Peace John Anderson. The certificate was recorded in May 1836 with County Clerk A. L. Ely.

Requests of the Vital Records Division over the last 13 years tell a lot about the lives of constituents in Allegan County. Purchases of Concealed Pistol Licenses show more volatility than any of the other transactions. Applications for CPL's more than tripled from 2010 when there were 853 to the year 2020 when there were 2,855.

Trends in Marriage Licenses range from the 850 issued in 2018 to the low of 669 in 2020.

Notary Public Applications from 2010 to 2022 varied from a low of 119 at the beginning of the period to the peak in 2019 of 262 accruing 235 in 2022.



The trend in home births in Allegan County is a gradual but upward trend. From a low of 13 in 2010, those numbers have more than tripled to 42 in 2022.

The number of deaths recorded in Allegan County have increased from a 2011 low of 598 to the 986 in 2022.

After hitting a high of 751 in 2011, the number of people Doing Business under an Assumed name (DBA's) has seen a gradual decline in applications during the 13 year time period. Their number bottomed out at 410 during 2020.

Veterans recording DD 214's has seen a resurgence under Clerk Genetski. Up from a low of 1 recorded in 2016 (the year before he was seated), there were 44 processed in 2017 and with the exception of COVID 19's affecting 2020, every year has been in double digits.

<u>Trends in Processing DD 214's for</u> Our Veterans

One of the most important (and least known) services the Vital Records Division offers is the recording of military discharge papers otherwise known as DD 214's. Most often, when service members return to civilian life,

Allegan County clerk urges veterans to file discharge papers

ALLEGAN COUNTY — The Allegan County clerk's office processed two dozen honorable discharge papers from military veterans in 2018.

This is the second-highest number of DD 214's, Certificate of Release or Discharge, filed with the office since 2005 when the office started tracking them. The highest number of papers filed in Allegan County was 44 in 2017.

"In the last two years, we have processed more veterans' discharge papers than the previous seven years combined," said Bob Genetski, Allegan County clerk. "Our campaign to help veterans connect more easily with benefits they have earned is working."

the military issues only one copy of their papers of honorable discharge. If the papers are lost or destroyed, the federal government can be very difficult to deal with when a veteran tries to replace the originals.



In July 2021, Clerk Genetski joined with members of VFW Post 7911 in Clyde Township to recognize the post's 75th Anniversary of Service.

These papers are extremely important for veterans as they apply for VA benefits, GI Bill benefits, and even to obtain the "Veteran" designation on a Michigan Driver's License.

For this reason, the Office of the County Clerk is encouraging all Allegan County veterans to file their papers of honorable discharge with the office. It's a quick process; it's FREE, and it gives veterans and their families peace of mind.

When a veteran comes in to file his or her honorable discharge papers, he or she will receive the original papers back, a free certified copy, and the

individual and the veteran's designated heirs will have access to free certified copies for all of their needs for the rest of their lives. As well, all of the information on the DD 214 (including whether the document is on file with the clerk) is non-public.

Since Clerk Genetski took office in 2017, the number of DD 214's registered has been in double digits every year but one. In 2022, the 19 DD 214's registered represent the 4th highest number since 2004.

In April of 2021, the Clerk's Office was able to roll out the new Allegan County Veterans ID card. This is a free benefit extended to those who have been honorably discharged from U.S. Military service and who file their DD 214 (papers of honorable discharge) with the Clerk's Office.

The process to obtain the card is quick and easy. The former serviceman or woman brings his or her original DD 214 to the Clerk's Office to be registered (or brings an ID to confirm that the papers are already on file). The deputy clerks in the office make a copy, give the original DD 214 back to the veteran, take a quick digital




photo and upload it before printing the card. The entire process takes no more than 10 minutes.



Veterans can present the cards at participating businesses throughout the county and in fact throughout the U.S. to obtain discounts and benefits. Each eligible Allegan County veteran is presented with a booklet of such benefits.

The office has presented 67 Veterans ID Cards since the benefit was first rolled out. Prior to the release of the ID cards, this benefit was

CIRCUIT COURT RECORDS

DIVISION OVERVIEW

The Circuit Court Records Division of the Clerk's Office is the fundamental access point to the 48th Circuit Court for all parties in a civil, criminal or Family Court matters. This office is where customers have their first interaction with the court system. The talented deputy clerks work hard to make any experience at our service window as seamless and pleasant as possible by providing information regarding procedures, access to court related resources, Friend of the Court and the Legal Assistance Center as well as by providing access to public court records.

Our services include processing documents necessary to initiate new cases filed with the Court as well as receiving, reviewing, and processing all documents pertaining to pending legal matters before the Court, pulling records for the scheduled hearings, and clerking in the courtroom. Our staff is friendly and polite – emphasizing customer service- knowing that many of the people who need our service might be navigating a complex legal system for the first time.



Reporting to State Agencies

agencies. Depending on the situation, the Office might communicate with the Michigan Secretary of State, Michigan State Police, and/or the Michigan Department of Corrections. These reports help create accurate records for the public to access at the state level. In addition, all cases involving a motor vehicle are abstracted to the Secretary of State so the state may take necessary actions to uphold and protect the citizens of Michigan.


Restitution, attorney fees, bonds, Victims' Rights Fund, fines, state minimum costs, filing fees, motion fees, jury trail fees, garnishment & subpoena fees. In 2022, the Circuit Court Clerk's office collected approximately 1 million dollars.

The Division serves as a pass through entity whereby restitution payments are collected and sent to victims of crimes.

The Division is also responsible for processing adoptions.

Individual deputy clerks from this office serve as clerks in hearings of the 48th Circuit Court.


Overview of the 2,447 New Cases Filed in the Circuit Court in 2022

The adoption process in Allegan County begins in the Circuit Court Records Office. Deputy clerks work with petitioning parents, Family Court, adoption agencies and attorneys to facilitate the process. While all adoptions in Michigan are closed to the public, once a year the Clerk's Office participates in "National Adoption Day" during which families engage in a public ceremony at the Courthouse. This ceremony is one of the most moving and heartwarming events each year anywhere in Allegan County.

The Circuit Court Records Division helped process 54 adoptions in 2022.



A ten year trend in Family Court Filings other than Adoptions in the Circuit Court Records Division.



Friend of the Court

This Division interacts with the Friend of the Court as well. The Office processes family cases initiated by F.O.C. and can also attest a "true copy" of a Friend of the Court order.

Annual Report to the SCAO

The Michigan State Court Administrator's Office annually requests of all counties a caseload report that identifies important case data, such as the number of new cases filed each year as well as the age of each case from the initial filing date to the date of disposition. Each year, the Circuit Court Records Department helps prepare and submit this data to the state. The Clerk's Office collaboratively works with the Circuit Court staff to review these statistics and improve upon the previous year's data. Improvements to such procedures work to ensure that the County's residents are satisfied with their overall court experiences.

<u>Collection and Disbursement of Monies for the Court</u>

The Clerk's Office is responsible for receipting in all payments for the 48th Circuit Court. This includes all statutorily mandated fees and court ordered fines, costs, restitution and juvenile delinquent fines for family court. These payments may be made at the Circuit Court Records window or online.

During 2022, the Circuit Court Records Division received \$220,473.54 for Adult Cases and disbursed \$290,142.54 to crime victims. Collections from juveniles during the same period amounted to \$24,109.41, and \$22,305.18 was paid out to victims of crime.

OFFICE OF THE REGISTER of DEEDS

By Law, the Register of Deeds is the "keeper of Public Record" for land documents. The recording of a document with this office does not make the document legal. The action of recording makes the document public.

Division Overview

The Office of the Register of Deeds records all documents pertaining to real property including deeds, mortgages, liens, powers of attorney, certificates of trust; federal, state, and MESC tax liens; master deeds and plats; sheriff's deeds and redemption certificates.

The hardworking deputies in the Register's Office must be familiar with more than 200 different types of legal documents and the



unique statutes for recording each of them. ROD staff works closely with attorneys, real estate agents, banks, title agencies and the public. The number one goal is to provide customer service – polite, professional, accurate and timely.

In 2022, the Register's Office broke a record for the amount of money taken in for the third year in a row even though recordings decreased from the all-time high of 31,015 in 2021.

The year marked the third full year of the County's new records system that has increased efficiency and effectiveness in the office.

The new technology includes the long awaited service of an online searchable database for land records that allows customers to search on the Internet and purchase copies on record 24 hours a day from any location with internet service.



Finally, in 2022- the office rolled out the new *Property Fraud Alert* system. Available for free for anyone who owns property in Allegan County, subscribers can sign up to receive a phone call or email whenever a recording is made at the Register's Office relative to their property.

Property Fraud Alert

Allegan County residents worried about property fraud and title theft can now rest a little easier thanks to a new tool that will alert them if their homes or land become targets of potential title theft. Property Fraud Alert is an online subscription service offered to the public that allows residents to have their names monitored within the Register's Office in order to track possible fraudulent recordings that affect their property. With Property Fraud Alert, subscribers will be notified when the name they have submitted is used in any recording activities within the Register's



Office. This had been the number one most requested service of the office from constituents.

Bob Genetski announced this new FREE SERVICE in October 2022.

Signing up for the *Property Fraud Alert*

service is quick and easy. Homeowners will go to the website. From there, they should click on the link that reads Property Fraud Alert. Then, they will click on a link to review the terms of the service and agree to them. After that, on the secure website, they will input their first and last names as well as their option to receive the alert via email or phone call. Then, residents will receive a confirmation email that they are signed up. If the landholder does not have Internet access, he or she can call the office at (269) 673-0390 to sign up as well.





Document Recording


In 2022, there was a decline of 6,996 recordings logged at the Register of Deeds Office from the previous year. The all-time high of 30,015 recordings occurred in 2021 while 2022 saw 24,019.



Trends in Recordings: The two most frequently recorded documents at the Register of Deeds Office are land transfers and mortgage documents. During 2022, the number of both categories declined from the year before as mortgage documents dropped from 7,883 to 5,268 and land transfers declined from 7,128 to 6,341- an indication that the formerly red hot West Michigan real estate market has cooled off.



With each document recorded at the Register of Deeds, the Office collects \$30. Of that amount, the County General Fund receives \$21 while \$5 of that goes to the County Automation Fund (for upgrading technology in the Office). The remaining \$4 goes to the State Remonumentation Fund.



Trends in Monies Collected in the Register of Deeds Office from 2015 to 2022

The chart above shows a breakdown of the total monies collected for transactions at ROD for 2015 to 2022. The total amount realized during 2022 was \$9,949,217.50 – the largest number ever receipted to the county.

Definitions:

State Real Estate Transfer Tax: collected on all deeds recorded and sent to the State of Michigan – 1.5% of this is sent to the County General Fund as an administrative fee (\$111,257.19 for 2022).

County Real Estate Transfer Tax: collected on all deeds recorded and sent to the County General Fund.

Recordings Fees: collected on every document recorded (of the nearly 200 hundred different types of documents) most of which goes to the County with a small portion going to the state (see the pie graph on the previous page for a breakdown).


Remonumentation Fees: collected on every document recorded (with the exception of State Liens, Federal Liens, County Treasurer documents and MESC Liens) and sent to the state for the cost of surveying land corners. The monies are collected as part of the \$30 recording fee with the County General Fund receiving 1.5% as an administrative fee.

Copy Sales: collected on each document - \$1 per page and \$.20 per image (bulk sale to two title companies). This money goes to the County General Fund.



Passport Services

The Register of Deeds Office helped customers from Allegan County (and beyond) to obtain their United States Passports by accepting a record 392 Passport Applications in 2022.


The fee a customer pays for obtaining a routine passport through the office is \$165 (which was \$145 until a mandated increase by the federal government that went into effect in December 2021). With the change, \$130 of the total goes to the U.S.

Department of State while the remaining



\$35 is collected by the Register of Deeds Office and goes into the County General Fund.

Blank application forms are available in the office or online, and in addition to the check or money order, a customer will want to bring in a valid photo ID and supporting documents (such as a birth certificate). The Register of Deeds Office is pleased to offer passport size photos taken in the Office for initial applications for \$10. Customers may still bring their own passport size photos if they wish.



In 2022, the Register of Deeds Office set a record for the highest number of Passport Applications processed with 392. This is a 32.9% increase from the 263 in 2021 and more than 3 times the 10 year low of 129 set during 2020.



The Office also took in \$2,795 for taking passport photos during 2022, up by \$1,175 from 2021.

REAL ID UPDATE:

The updated deadline to obtain a REAL ID compliant Driver's License has been delayed until May 7, 2025. After that date, under federal law travelers will need to present a REAL ID compliant identification card to board an airplane within the



United States or to enter federal facilities. The new requirement is one more reason to visit the Register of Deeds Office because a U.S. Passport is considered valid documentation to obtain the REAL ID.

Each deputy in the Office is annually certified as a Passport Acceptance Agent by the United States Department of State. Passport services are available from 8AM-4:00 PM Monday – Friday Unlike the competition, there is no appointment necessary. These visits take between 20 and 30 minutes provided the applicant has all of his or her necessary documentation.

Centennial Farms and the Register of Deeds
As the number one agriculture producing county in the state, Allegan County is blessed with many families that have been tilling the land for generations. Allegan County families that have farmed the same land for 100 years or more will want to visit the Register of Deeds Office for a copy of the deed or mortgage documents that show the history of the property & ownership of the working farm. This is the documentation the Historical Society of Michigan will request for the Michigan Centennial Farm Program.

Other Duties and Responsibilities of the Clerk - Register

The Allegan County Plat
Board: State Law directs the
County Clerk, the Register of
Deeds and the County
Treasurer to serve on the
County Plat Board. The Plat
Board makes certain that
the proper county agencies
have reviewed and

approved any new plats.





The County Election Commission: The County Clerk serves as clerk to the County Election Commission, which is chaired by the Probate Judge. The Treasurer serves as well on the Board that approves ballots, precinct consolidations and reviews recall language.



The Board of Canvassers met four times in 2022 - three times to certify elections and once in December for the statewide recount.

County Board of Commissioners: the County Clerk serves as Clerk to the Allegan County Board of Commissioners.

County Board of Canvassers: The Clerk serves as Secretary to the Allegan County Board of Canvassers. The Canvassers are responsible for canvassing and certifying elections.



Ongoing projects, outstanding issues, and concerns for the future...

Navigating the numerous law changes following Proposal 2 of 2022: In the November Election

of 2022, after being falsely sold to voters by a radical activist groups and a gullible media as "reform", a statewide initiative- Proposal 2-passed to amend the Michigan Constitution. The results will greatly decrease election security and make it much easier for people to vote illegally. The changes will also create a ridiculous amount of work & new costs for local jurisdictions to cover for things like: prepaid postage on absentee ballots and AV ballot applications; 9 days of early in person voting for which each jurisdiction will have to purchase a new tabulator; and a requirement for thousands of Michigan municipalities to



add new drop boxes to accept ballots. In addition, clerks and election inspectors will have to undergo many hours of added training to explain how to implement the numerous new procedures that derive from Prop 2.

Staffing for a Third Circuit Court Judge: With the Legislature approving a third 48th Circuit Court Judge in 2022, the Circuit Court Records Division will need at least 2 FTE's to serve as clerk and maintain the docket for a new judge. The FTE's will need to be in place when the judge is seated after the 2024 General Election.

Caseload Increase from Michigan Clean Slate Legislation: In October 2020, the Legislature enacted a group of bills collectively known as the "Clean Slate" package. These bills impact the



rules and procedures an individual may use to have a prior conviction set aside. In addition to making several changes to the existing paper application processes and eligible offenses, the Clean Slate package also created a new automatic process to set aside eligible offenses without requiring an individual to file an application. These changes will greatly increase the workload for

the Circuit Court Records Division while requiring implementation and training on a lot of new technology.


