REQUIREMENTS FOR NON-RESIDENTS TO MARRY IN MICHIGAN

**Please note if you are an out of State resident and applying for a license in Allegan County – the ceremony must take place ONLY in Allegan County to be valid. Please call our office to verify the address is in Allegan County.

Please find enclosed:

- 1. One (1) Affidavit for License to Marry
- 2. "Getting Married in Michigan? What You Need to Know" (back side of Affidavit)
- 3. Educational materials regarding sexually transmitted diseases

The Affidavit for License to Marry must be completed in full. It must be **typed or printed legibly.** It is important for you, as the applicants, to provide the complete first, middle and last name for both applicants and their parents (no initials in place of a name, please). Note: Both the city and state of birth are needed for the applicants. Only the state is needed for parents' birthplace.

The applicants' signatures on the Affidavit must be witnessed by a notary public no more than 33 days before the wedding and no less than 3 days before the ceremony. Please be aware we are only open Monday through Friday; we are not open on weekends for marriage license pickups.

There is a three (3) day waiting period for the license – Once the form is notarized that starts the three (3) day waiting period. The ceremony must take place within 33 days from the date the Affidavit is witnessed by the notary. Please be sure to note in the appropriate place on the Affidavit whether you would like us to mail the license to you and at what address or if you plan to pick it up.

- 1. The completed, signed and notarized Affidavit
- 2. \$30.00 application fee (make check or money order payable to **Allegan County Clerk**)
- 3. Photocopy of driver's license or state I.D. for both of the applicants

GETTING MARRIED IN MICHIGAN? WHAT YOU NEED TO KNOW....

Who can marry....

To be able to marry you must not be married to someone else. (MCL 551.5) *If you have been married before, you may be asked to document that the earlier marriage has ended due to death, divorce or annulment.* To obtain a Michigan marriage license the couple must be 18 years of age or older and be able to enter into legal contracts. (MCL 551.103) As proof of age, the person who intends to be married, in addition to the statement of age in the application, when requested by the county clerk, shall submit a birth certificate or other proof of age.

Where to apply and where to marry....

If either of the couple are Michigan residents, they must apply with the county clerk where one or both have legal residence. Once the license is issued, Michigan residents can marry anywhere in the state. (MCL 551.101)If neither of the couple lives in Michigan, they must apply with the county clerk where the marriage ceremony is to be performed. Once issued, the license can be used only in the issuing county. (MCL 551.101)In either case, the use of a Michigan License is not valid outside the State of Michigan.

Who can you marry....

There are restrictions on who someone can marry. (MCL 551.3 and 551.4) An individual shall not marry the individual's parent, sibling, grandparent, child, grandchild, stepparent, grandparent's spouse, child's spouse, grandchild's spouse, spouse's parent, spouse's grandparent, spouse's child, spouse's grandchild, sibling's child, parent's sibling, or cousin of the first degree.

The three day waiting period....

Generally, a marriage license is not issued for a period of three days from the date of the application. Applicants can, however, request a waiver of the three day waiting period from the clerk issuing the license. (MCL 551.103a)

Special notice of perjury....

Note that the application for a m arriage license is a sworn affidavit. Making false statements in the marriage license affidavit is **an act of perjury** which is a prosecutable offense. (MCL 551.108)
