## Public Transportation prior to 2020


Service was only available for individuals that lived within 1 mile from major roadways.

Service was not available on weekends and evenings. A study conducted during the development of the 2011

Transportation Strategic Plan found 25% of survey respondents stated a lack of transportation prevented them from looking for, getting, or keeping a job.

Program revenue was largely dependent upon partnerships with agencies. This limited the number of trips individuals were able to take, since agencies had scheduling priority. Consequently, 36% of respondents from the 2011 strategic planning study stated a lack in transportation services prevented them from attending medical appointments in that last year.



In 2019, there was an average of 269 trip denials per month - individuals were calling ACT for service, but their rides were unable to be scheduled to various limiting factors.

Through the 2019 survey, the community expressed support towards the prioritized expansion of public transportation through a tax limitation restoration.



# Public Transportation prior to 2020

Between 2018-2020, there was a heavy reliance on fund balance to maintain operations, with a rapid decrease in agency service and corresponding contract revenue. It was estimated that by 2021, fund balance would be depleted, and service would be limited to contracted service. There was also future funding uncertainty for Specialized Services.

Primarily, trips were reserved for Agency Partners (such as Commission on Aging, Outlook Academy, MDHHS, Michigan Works and Community Mental Health). Remaining availability was reserved for dialysis patients, medical trips, and seniors and individuals with disabilities. Only about 5 percent of trips were reserved for Job Access/Employment.



## Service Expansion Impact

# Impact # 1 Growth

Funding available to have more drivers on the road. There are now 21 drivers at ACT and trip denials have been cut in half. During the summer months, there were less than 50 trip denials/month (on average).

#### Impact # 2

Equity

Communities previously under-served by Public Transportation are now able to access employment opportunities and medical appointments. There are now more trip requests from outlying areas, and a wider diversity in trip purpose.

#### Impact #3

Collaboration

The hiring of a new Transportation Director (June 2022) and Transportation Coordinator (April 2023) has enabled more staff hours to be allocated towards outreach and strengthening community partnerships. Current transportation initiatives are focused on the Community Health Improvement Plan areas.

# Impact #1: Program Growth

Through a 2019 survey, the community expressed support towards the prioritized expansion of public transportation through a tax limitation restoration, which was later approved by the voters. As a result, Transportation service hours have now been expanded to Monday through Friday 5:30am - 7:00pm and Saturday 8:00am - 3:00pm.

# Impact #1: Program growth

More drivers on the road - Increase to the number of routes per day (11-12 routes per day, increased to 17-19 per weekday)

Increase in revenue miles traveled (17% increase from FY 2022 to FY 2023).


**Less trip denials** - up to 83 percent lower during the summer months

**Expanded trip purpose -** expanded transportation opportunities improves the quality of life for individuals.

**Farebox (cash) revenue** - 24 percent increase (higher frequency of \$5 one-way fare being paid for individual, non-agency out-of-county trips)




Fiscal year (October 1 - September 30)



Allegan County Transportation now operates seven new buses powered by propane autogas to help the county meet air quality attainment goals and save taxpayer dollars.

With local funding available to offset operational expenses, routes are built around individual needs.

## Impact #2: Equity

The Farmer's Market transportation initiative was intended to help improve access to fresh food in addition to supporting local businesses and farmers. The goal next year is to expand the outreach of this program to include other parts of the county.

Expanded service countywide also helps ensure individuals are able to schedule trips to get groceries throughout the week.

## Lacy's Story

Service expansion has opened up employment opportunities for community members, such as Lacy, who was a passenger prior to coming to ACT through Michigan Works.

Lacy was able to secure full-time employment status through a partnership with MI Works that paid for training expenses, including a CDL license. In her role, Lacy sees how service expansion is helping individuals in the community get to work, especially those with later work schedules.

## Impact #3: Community Presence.

Service Expansion enabled the hiring of a Program Coordinator in April 2023. This person is primarily responsible for building community relationships and strengthening agency partnerships.






### Future Projects

#### **New Technology**

By the end of the year, ACT will have new scheduling and dispatching software, called Via Mobility. This will improve efficiency and allow more flexibility and access. The new technology will greatly enhance the customer experience.




#### **Propane Infrastructure**

Upon the arrival of seven new propane-powered buses in Jul-Aug 2023, ACT will be looking into longer-term refueling infrastructure at the Transportation facility. On-site fueling will increase tax-payer savings.



#### **Customer Experience**

Future projects include launching a customer-facing mobile application for scheduling. Staff remain committed to community education on mobility options through travel training, agency presentations, and updated printed materials.



## Future Projects

#### **Regional Collaboration**

The MAX in Holland, MI is currently undergoing route realignment. Members of the team at ACT have participated in focus groups and plan to coordinate with other transit agencies on future regional mobility initiatives.



#### **Strategic Partnerships**

Through participation in groups such as the Multi-Agency Collaborative Council, ACT remains committed to collaboration and coordination with area programs and services.



**Improved Visibility** 

Plans are underway to develop an outreach and marketing plan for 2024. There will also be an Open House at the Transportation facility at the beginning of the new year to highlight new and ongoing projects.
