SUBJECT: Materials Management Planning

Michigan's Solid Waste Program has been updated with the passage of significant amendments to Part 115, Solid Waste Management, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended, that became effective on March 29, 2023. The amendments require that existing county Solid Waste Management Plans be replaced with new Materials Management Plans (MMP) that focus on sustainable materials management approaches, such as recycling and composting, instead of just landfilling waste.

In accordance with Part 115, the Department of Environment, Great Lakes, and Energy (EGLE) is initiating the materials management planning process as of January 8, 2024.

Counties, boards of commissioners, or elected executives are given the first opportunity to assume authority over MMP development and implementation. If the county accepts this authority, they are required to consult with adjacent counties about the option of preparing a multicounty plan and submit a Notice of Intent (NOI) to prepare an MMP within 180 days of the date that the EGLE Director initiates the process. If the county declines this authority, they must advise all the municipalities in the county and the regional planning agency of their decision. The regional planning agency or all of the municipalities, acting jointly, may assume planning responsibilities if the county declines. If the county, municipalities, and regional planning agency all decline the responsibility to prepare the plan, EGLE may prepare the MMP.

The NOI to prepare the MMP will be submitted via an online platform. The link to the submission platform can be found on the Materials Management Planning website at: www.Michigan.gov/EGLEMMP or directly at https://www.surveymonkey.com/r/EGLENOI. Completion of the NOI submittal will include documentation, by resolution or similar mechanism, from the entity accepting planning responsibilities; documentation of consultations with adjacent counties; and if pursuing a multicounty plan, an executed interlocal agreement. Submittal of the NOI begins the three-year timeframe for MMP development and approval.

Materials management planning will be the foundation of a more sustainable materials management framework in Michigan. To assist with this transition, grants will be available to every county for developing and implementing the MMP, with additional SUBJECT: Materials Management Planning Page 2 December 20, 2023

Board Resolution

Board Resolution passed in December which identifies the BOC as the County Approval Agency, and provides direction for the process.

- 1. No good numbers on diversion due to waste going to three different landfills
- 2. Not sure about how a multi-county plan would work prefer a multi-county process

- Working with neighboring counties with development and needs
- 2. Swapping recycling services with neighbors for mutual benefit
- 3. Community interest in organics recycling

Kent County's Material Plans Revision Process

Van Buren County's Material Plans Revision Process

Duties of County Approval Agency

County Approval Agency is the Board of Commissioners

The County Approval Agency (CAA) is the entity that assumes responsibility and authority over the MMP. The CAA will be responsible for approving and implementing the MMP, determining whether to pursue multicounty planning with adjacent counties, and filing a Notice of Intent.

- Primarily responsible for all aspects of the Materials Management Plan(MMP)
- Responsible for MMP implementation
- Consults with adjacent counties regarding preparing a multicounty MMP prior to filing the Notice of Intent (NOI)
- Appoints the Designated Planning Agency (DPA)
- Oversees the creation and implementation of the DPA's work program
- Utilizes the MMP Grant funds for MMP development and implementation
- Approves the MMP prior to municipal approval
- Approves MMP modifications, if needed
- Certifies to EGLE the progress toward meeting all components of its materials management goals

Duties of Designated Planning Agency

DPA will initially be Resource Recovery Coordinator until grant funding is secured and a consultant and/or contract employee can be utilized

The Designated Planning Agency (DPA) is the agency, and an individual within that agency, identified as the primary contact person for administering and preparing the MMP.

- Serves as the primary government resource in the planning area for information about the MMP and leads the MMP development process
- Under the direction of the Materials Management Planning Committee (MMPC), prepares the MMP using the EGLE provided format, solicits public comment, and obtains MMP approval
- During the preparation of the MMP, solicits the advice of and consults with the following organizations:
 - Municipalities, various organizations related to materials management, and the private sector, such as materials management facility operators, in the planning area.
 - The county or regional planning agency.
 - Counties and municipalities in counties that are adjacent to the planning area.
