**WHEREAS**, an Order Laying Out and Designating the Blue Star Highway Drain Drainage District was entered on April 11, 2022, and

**WHEREAS**, the Township has determined that the location, establishment and construction of the proposed drain is necessary for the public health in the Township pursuant to Chapter 4 of Public Act 40 of 1956, as amended; and

**WHEREAS**, the Township will be liable for an assessment at large against it for a percentage of the cost of the proposed drain.


**NOW, THEREFORE BE IT RESOLVED THAT**, the Township Board does authorize the filing of a petition for the location, establishment and construction of the drain.

**BE IT FURTHER RESOLVED THAT** the Supervisor is authorized to execute the petition for the location, establishment and construction of the drain.

**BE IT FURTHER RESOLVED** that the Clerk shall forward to the Allegan County Drain Commissioner a copy of this Resolution for the petition for the location, establishment and construction of the drain.



Land generally within the south half of the northwest quarter of Section 10, the northeast quarter of the southwest quarter of Section 10, the northwest quarter of the southwest quarter of Section 10, and the northwest quarter of the southwest quarter of the southwest quarter of Section 10, including entire and portions of unplatted parcels and portions of platted parcels of Gaslight Estates and Brookwood Estates plats.
