## I. Approval of Agenda

# II. Action Items from previous meeting

- A. Jill will reach out to the owners of the target locations where wells need to be drilled to get agreements signed. DONE
- B. Jaclyn will research whether Kalamazoo or Van Buren have any groundwater research underway. DONE
- C. Zach will find out where the Ottawa monitoring wells are and how many of the Ottawa monitoring wells are actively transmitting data to the central systems. Zach will check on whether Barry County or Kent County have any monitoring wells. **DONE**

### III. Discussion

A. Jaque Billete, new Allegan County Health Officer, introduced herself in person

### B. Monitoring Wells Update (Kapenga)

- 1. R. Sarro presented update on status of agreement for wells to be located on Township properties. Memorandum of Agreement almost ready for use.
- 2. R. Rapp stated discovery Center is willing to host monitoring well on their site. Nate from Michigan Geologic Survey and Discovery Center are coordinating site visit to establish exact location of well. Action is in hands of MGS.
- 3. R. Rapp noted opportunity to provide education about groundwater in the form of a kiosk display and classes for students. R. Kline-Robach to reach out to Kelly at Discovery Center.
- 4. D. Wedge said the 911 radio tower on 30th St. in Monterey Township is owned by the County. The land is leased to a farmer for agriculture. A monitoring well can be placed on the site as long as it does not interfere with the farming or radio tower operations. NPSCS will need to be notified. R. Rapp to contact MGS to meet at site and set stake in ground for the actual monitoring well location.
- **5.** J. Hulst asked that MGS notify work group in advance when drilling will start, as some members of the work group would like to watch and learn.

#### C. Private Well Assistance Program (Rapp)

- 1. R. Sarro updated group on status of draft scope of work. Recent meeting held with ACCF. R. Sarro concerned about the administrative fees. Wants to see that highest amount of funds possible go to homeowners.
- 2. R. Sarro stated as long as County can get an agreement in place by October 2024, the commitment for ARPA funds will be met.
