OF DRAINAGE DISTRICT BOUNDARIES &
NOTICE OF DAY OF REVIEW OF APPORTIONMENTS**

Notice is Hereby Given that on **Wednesday, August 28, 2024**, the Allegan County Drain Commissioner will hold a Day of Review of Drainage District Boundaries from 9 a.m. to 5 p.m. at the Office of the Allegan County Drain Commissioner, 113 Chestnut Street, Allegan, Michigan 49010. At that time and place, the Drain Commissioner will hear the proofs and allegations and carefully reconsider and review the description of lands comprising the Drainage Districts for the Drains listed below, and determine whether the addition or deletion of lands will more accurately define the boundaries of the land benefitted by the Drains and is just and equitable pursuant to Section 197 of 1956 PA 40, as amended. The Drains are located and established in the following municipalities, and a general description by section number of the lands proposed to be added or deleted in whole or in part include the following:

You are Further Notified that persons aggrieved by the decision of the Drain Commissioner to add or delete property to or from a Drainage District may seek judicial review in the Allegan County **Circuit Court** within ten (10) days of the decision.

Notice is Further Hereby Given that also on **Wednesday, August 28, 2024**, the apportionments for benefits to the lands comprised within the Drainage Districts listed above, will be subject to review for one day from 9:00 a.m. until 5:00 p.m. at the Allegan County Drain Commissioner’s Office, located at 113 Chestnut Street, Allegan, Michigan 49010. At the meeting to review the apportionment of benefits, I will have the tentative apportionments against parcels and municipalities within the Drainage District’s that are subject to a special assessment available to review. Pursuant to Section 155 of the Michigan Drain Code of 1956, as amended, any owner of land within the special assessment district or any city, village, township, or county feeling aggrieved by the tentative apportionment of benefits made by the Drain Commissioner may appeal the apportionment within ten (10) calendar days after the Day of Review of Apportionment by making an application to the Allegan County **Probate Court** for the appointment of a Board of Review.

Any drain assessments against land will be collected in the same manner as property taxes. If drain assessments against land are collected by installment, the landowner may pay the assessments in full with any interest to date at any time and thereby avoid further interest charges.

In addition to the assessed parcels and tracts of land in the Section numbers listed above, shall be specially assessed at large for benefits of the maintenance of the aforementioned drains in each township.

NOW THEREFORE, all unknown and non-resident persons, owners, and persons interested in the above-described special assessment district, and you:

Clerk of Allegan County; Allegan County Road Commission; Township Supervisors, City or Village Clerks; are hereby notified that at the time and place aforesaid, the apportionment of benefits and the lands comprised within the aforementioned Drainage Districts will be subject to review.
