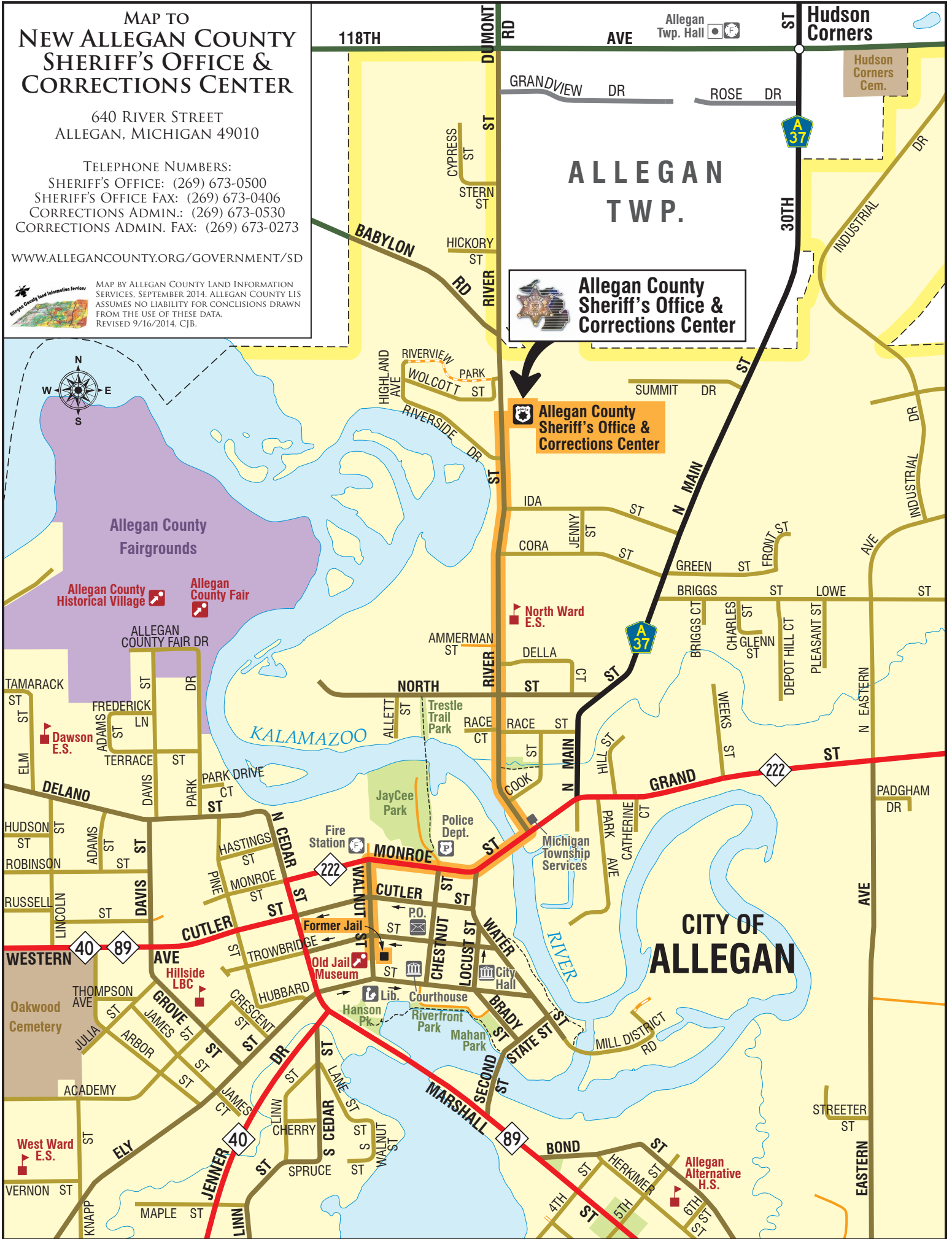

# DIRECTIONS TO NEW ALLEGAN COUNTY SHERIFF'S OFFICE & CORRECTIONS CENTER

## From the Former Jail Facility downtown:

Follow **orange highlighted line** on the map.

- From the front door of the former Jail Facility on Walnut St in downtown Allegan, continue north on Walnut St to M-222/Monroe St.
- Turn right onto M-222/Monroe St and continue east for three blocks across the Kalamazoo River bridge.
- Just after crossing the river, turn left onto River St.
- Follow River St north for ½ mile to Sheriff's Office & Corrections Center.

## From the Northeast (Wayland, Grand Rapids):

- Follow US-131 SOUTH to the Martin area.
- Take Exit 55: M-222 - Martin/Allegan. Turn right.
- Follow M-222 west for 9½ miles into Allegan.
- One block beyond A-37, turn right onto River St.
- North ½ mile to Sheriff's Office & Corrections Center.

## From the Southeast (Plainwell, Kalamazoo):

- Follow US-131 NORTH to the Martin area.
- Take Exit 55: M-222 - Martin/Allegan. Turn left.
- Follow M-222 west for 9½ miles into Allegan.
- One block beyond A-37, turn right onto River St.
- North ½ mile to Sheriff's Office & Corrections Center.

## From the North (Burnips, Hudsonville):

- Follow A-37 (30th St in Allegan County) south toward Allegan.
- Turn right onto 118th Ave and continue west ½ mile.
- Turn left onto River St and continue south ¾ mile to Sheriff's Office & Corrections Center.

## From the Northwest (Fennville, Saugatuck, Douglas, Holland):

- Follow M-40 SOUTH or M-89 EAST toward Allegan.
- At Jct M-222 in Allegan, turn left onto N Cedar St (M-222) for one short block.
- Turn right onto Monroe St (M-222) and continue east for about ½ mile.
- Just after crossing the river, turn left onto River St.
- North ½ mile to Sheriff's Office & Corrections Center.

## From the South (Gobles, Paw Paw):

- Follow M-40 NORTH toward Allegan.
- At Jct M-89 in Allegan, turn left to follow M-40/M-89 (N Cedar St) for two blocks.
- At Jct M-222, continue straight ahead on N Cedar St (M-222) for one short block.
- Turn right onto Monroe St (M-222) and continue east for about ½ mile.
- Just after crossing the river, turn left onto River St.
- North ½ mile to Sheriff's Office & Corrections Center.
