# Summary

Performs all of the essential duties of a Road Patrol Deputy in addition to supervising a patrol shift, overseeing all major incidents, coordinating training, command special units, review reports, maintain department equipment, conduct internal investigations, obtain warrants, assist multiple agencies, case oversight, grant writing, program administration and budgeting.

#### **Essential Functions**

Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions. This position has direct supervisory responsibilities and serves as a coach and mentor for other positions in the department.

- 1. Provides supervision to Road Patrol Deputies and any other sworn or civilian personnel including Detectives, Marine Patrol, Snowmobile Patrol, and Reserve Deputies.
- 2. Oversees the work of the Road Patrol Deputies and other sworn or civilian personnel through assistance, training and mentoring, monitoring their statistics, reviewing their reports, deploying resources appropriately, offering input on decision making, and directing their activities.
- 3. Respond to calls for service from the public and perform routine road patrol duties.
- 4. Oversee major crime scenes, accidents, and events in the County that could include natural disasters, large community events, death investigations, major property crime, missing persons, serious injury or fatal traffic crashes, and dignitary protection.
- 5. Provide training to department personnel and others in areas including Firearms, CPR, First Aid, Blood Borne Pathogens, Defensive Tactics, Drunk Driving Detection, Active Shooter Response, Evidence Collection, Crash Investigation, and Field Training.
- Command and supervise specialist units within the Sheriff's Office through on scene
  management of critical incidents, training and documentation of these incidents, review of current

- policies and tactics, budgeting, pre-planning for critical incidents, and selection of team members for specialty units.
- 7. Assists with internal investigations, the investigation of citizen complaints of misconduct, and participates on disciplinary boards of review.

- 4. Five (5) years of experience as a Deputy Sheriff.
- 5. Possess a Valid Michigan Driver's License.
