ANNUAL SEASON PASS APPLICATION

• Season Passes will be available for purchase the first business day of January for the current year.

- The Season Pass provides access for one watercraft trailer (or one vehicle carrying watercraft vessels) to the watercraft launches at Dumont Lake County Park, Gun Lake County Park, and New Richmond Bridge County Park. This includes personal watercraft, motorboats, jets skis, canoes, paddleboats, rowboats and kayaks.
- The Season Pass allows access to the Allegan County Equestrian Trails. Trailheads are located at Silver Creek County Park and Campground, and Ely Lake County Campground. The season pass covers all horses on one campsite or trailer for day riding.
- Season Passes DO NOT include campsite fees at any Allegan County owned or managed campground.
- There are no entrance fees to enter any Allegan County Park or Campground.
