DISCUSSION ITEMS:

1. Board viewed proposal January 28, 2021. Board set public hearing for February 11, 2021. Post hearing they will either approve the plan or send back for discussion.

- 2. Developer out of New York reached out to Aaron about Rock Tenn property. Discussed next steps to move forward towards a purchasing agreement. Developer builds "Work Force" housing, not low income housing but average wage housing. Currently developing the Studio 28 property in Grand Rapids. Aaron would like them to develop entire Rock Tenn property including riverfront. Developer and County in talks for a purchasing agreement. Brownfield Board wants to make sure in the agreement there are stipulations if they do not do what they say, and to write in specific plans for a development plan.
- **3.** Reviewing three different proposals currently. Approval should be made shortly and will be able to move forward. Planning to get an RFP drafted for demolition with a target for summer demolition.
- **4.** Area in City of Holland wanting to utilize Land Bank to provide clear title and make eligible for tax abatement.
