

**ALLEGAN COUNTY BOARD OF COMMISSIONERS
RESOLUTION PLEDGING FULL FAITH AND CREDIT
TO CASCO DRAIN DRAINAGE DISTRICT BONDS**

Minutes of a regular meeting of the Board of Commissioners of Allegan County, Michigan, held in the County on February 25, 2021, at _____ .m., local time.

WHEREAS pursuant to a petition filed with the Drain Commissioner of the County of Allegan, State of Michigan (the "Drain Commissioner"), proceedings have been taken under the provisions of Act 40, Public Acts of Michigan, 1956, as amended (the "Act"), for the making of certain intra-county drain improvements referred to as the Casco Drain Maintenance and Improvement Project (the "Project"), which is being undertaken by the Casco Drain Drainage District (the "Drainage District") in a Special Assessment District (the "Special Assessment District") established by the Drainage District; and

WHEREAS, the Project is necessary for the protection of the public health, and in order to provide funds to pay the costs of the Project, the Drain Commissioner intends to issue the Drainage District's bonds (the "Bonds"), in one or more series, in an amount not to exceed \$1,765,000 pursuant to the Act; and

WHEREAS, the principal of and interest on the Bonds will be payable from assessments to be made upon public corporations and/or benefited properties in the Special Assessment District; and

WHEREAS, the Allegan County Board of Commissioners (the "Board") may, by resolution adopted by a majority of the members of the Board, pledge the full faith and credit of the County for the prompt payment of the principal of and interest on the Bonds pursuant to Section 276 of the Act; and

WHEREAS, the pledge of the full faith and credit of the County to the Bonds will reduce the cost of financing the Project and will be a benefit to the people of the County.

NOW, THEREFORE, IT IS RESOLVED as follows:

1. The County pledges its full faith and credit for the prompt payment of the principal of and interest on the Bonds in a par amount not to exceed \$1,765,000. The County

shall immediately advance sufficient moneys from County funds, as a first budget obligation, to pay the principal of and interest on any of the Bonds should the Drainage District fail to pay such amounts when due. The County shall, if necessary, levy a tax on all taxable property in the County, to the extent other available funds are insufficient to pay the principal of and interest on the Bonds when due.

2. Should the County advance County funds pursuant to the pledge made in this Resolution, the amounts shall be repaid to the County from assessments or reassessments made upon benefited properties in the Special Assessment District as provided in the Act.

3. The Chairperson of the Board, the County Administrator, the County Clerk, the County Treasurer, County Executive Director of Finance and any other official of the County, or any one or more of them (“Authorized Officers”), are authorized and directed to take all actions necessary or desirable for the issuance of the Bonds and to execute any documents or certificates necessary to complete the issuance of the Bonds, including, but not limited to, any applications including the Michigan Department of Treasury, Application for State Treasurer’s Approval to Issue Long-Term Securities, any waivers, certificates, receipts, orders, agreements, instruments, and any certificates relating to federal or state securities laws, rules, or regulations and to participate in the preparation of a preliminary official statement and a final official statement for the Bonds and to sign such documents on behalf of the County and give any approvals necessary therefor.

4. Any one of the Authorized Officers is hereby authorized to execute a certificate of the County to comply with the continuing disclosure undertaking of the County with respect to the Bonds pursuant to paragraph (b)(5) of SEC Rule 15c2-12 issued under the Securities Exchange Act of 1934, as amended, and amendments to such certificate from time to time in accordance with the terms of such certificate (the certificate and any amendments thereto are collectively referred to herein as the “Continuing Disclosure Certificate”).

5. All resolutions and parts of resolutions are, to the extent of any conflict with this resolution, rescinded to the extent of the conflict.

Description

We are requesting Board Resolution consenting to the pledge of the Full Faith and Credit of the County for bonding on the Casco Drain in Casco Township, pursuant to the authorization provided in Section 276 of the Drain Code of 1956. Dickinson Wright and Bendzinski and Co. will be representing us. The cost of this project is \$1,765,000.

We have prepared a resolution for consideration at the next Allegan County Board of Commissioners meeting by which the County would pledge its full faith and credit to bonds issued by the Casco Drain Drainage District (previously known as Murdock Drain) (the "Drainage District"), in order to raise funds to pay the costs of a petitioned project being undertaken by the drainage district.

The project was initiated by a petition filed by Casco Township and found necessary by an independent board of determination convened to consider the necessity of the project. After design engineering was completed and other necessary preliminary actions taken, construction bids were taken for the project on January 25, 2021. After the construction bids were compiled, with a total cost of \$1,765,000, a day of review was held on February 2, 2021 from 9 a.m. to 5 p.m.

The costs of the project have been assessed to a special assessment district consisting of approximately 300 property owners served by the drainage district, as well as at large assessments against Casco Township, the County and County Road Commission (for county roads) and the Michigan Department of Transportation (for state highways). Prior to the day of review, each property owner and the parties with at large assessments received a notice informing them of the day of review. At the day of review each assessed party was able to ask questions about their assessment and raise any concerns about the assessments. At the conclusion of the day of review, the assessment roll was finalized and assessed parties had 10 days in which to appeal their assessments. That appeal period expired on February 12 and no appeals were filed.

The Drain Office plans to finance the project with the bonds, which will be payable over a 20 year period. The special assessments will be paid in 20 equal annual principal payments with interest on the unpaid balance, with corresponding payments due on the bonds each year. Highpoint Community Bank has offered to purchase the bonds at an interest rate of 2.74%.

The pledge of full faith and credit will allow the property owners and public corporations who are assessed to pay their assessments over time and provide a better interest rate in doing so, thus providing a substantial benefit to the residents of the County. Without full faith and credit, the Drainage District and hence the assessed parties might not be able to finance the assessments over time, requiring the assessed parties to come up with the full assessment up front or over a short period of time. Thus the pledge of full faith and credit provides a significant benefit to the property owners and the public corporations involved in this project.

Since the bonds are paid primarily by the assessments, the full faith and credit pledge acts as back up security for the bonds and it is rare that a county is called on to make a payment based on such a pledge. If there were a need for the County to make a payment based on the full faith and credit pledge, it would likely be a small amount for a short duration. A shortfall will normally not occur unless a property owner defaults on its assessment and the property is ultimately sold at tax sale for less than the amount of taxes and assessments owing. Such amounts will normally be relatively small since on the assessment rolls any one assessment against a benefitted property is only a small part of the whole, and the delinquency would most often only be for a few years of a multiyear assessment. Furthermore, county payments are usually short term since under the Drain Code the drainage district is required to levy a deficiency assessment against the district for the amount of any shortfall within a couple of years and when that assessment is levied and collected, the County would be paid back.

Should the Board of Commissioners approve the resolution at its meeting, the Drain Office currently plans to close on the bond issue with Highpoint Bank on March 16. After the resolution is adopted, we will work with the Drain Office on the final sizing of the bonds, reducing the par amount by the amount of prepaid special assessments that have been received. It generally takes about two weeks to put together closing documents and obtain signatures on them prior to the day of closing.
