RESOLUTION TO ADOPT THE ATTACHED FIVE (5) MEMBER PLAN

Whereas the Allegan County Apportionment Commission has set the number of county commissioner districts at five (5) members; and,


Whereas the districts in the attached plan are as nearly equal in population as is practicable; and,

Now therefore be it resolved that the Allegan County Apportionment Commission rescinds the map which was submitted on September 28, 2021 and adopts the attached five (5) member plan and instructs the Clerk to file this plan with the County Clerk, the Secretary of State for the State of Michigan, and the United States Department of Justice Civil Rights Division.

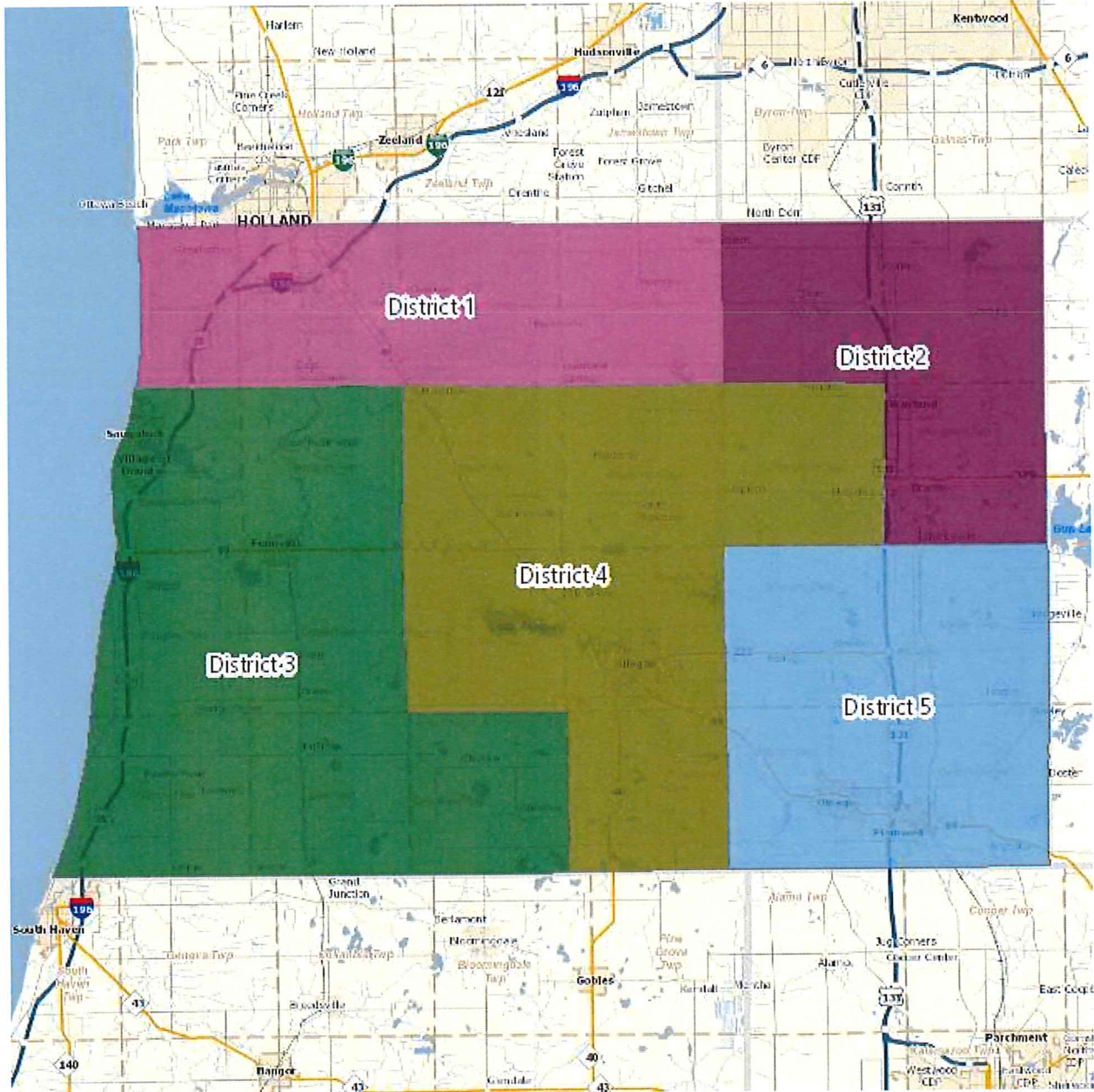

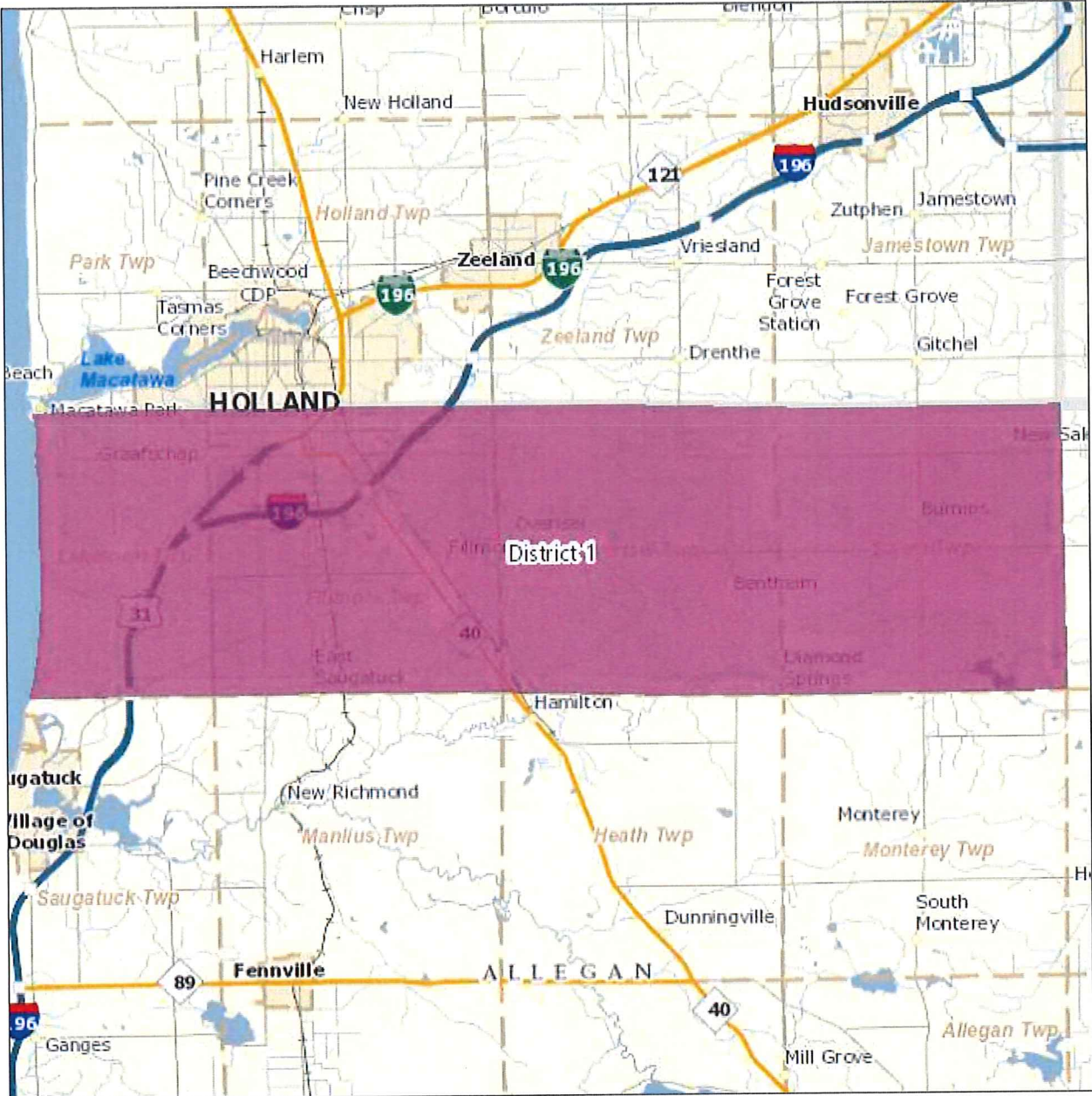

Allegan County District Map



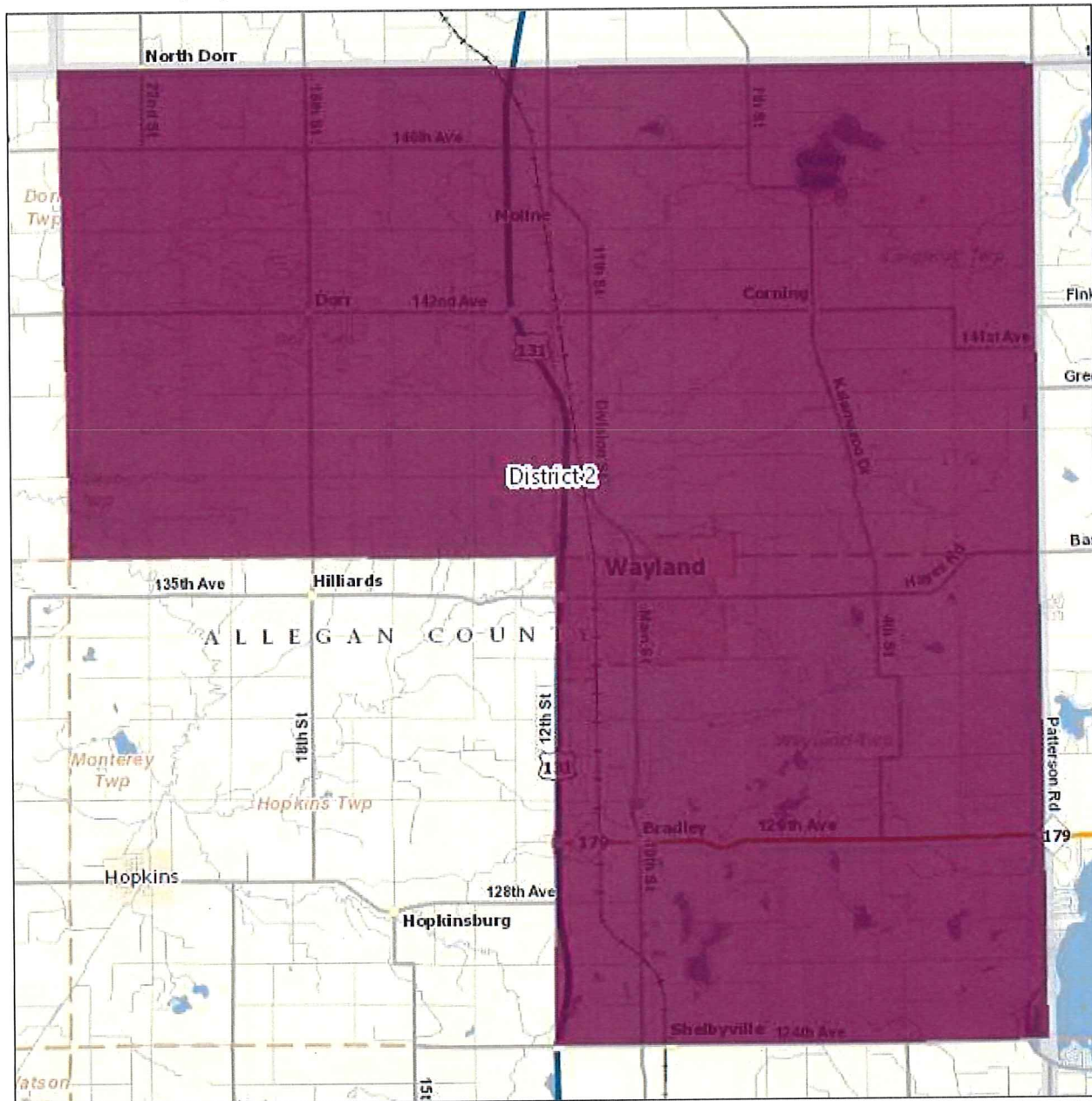

District 1 - population 24,725



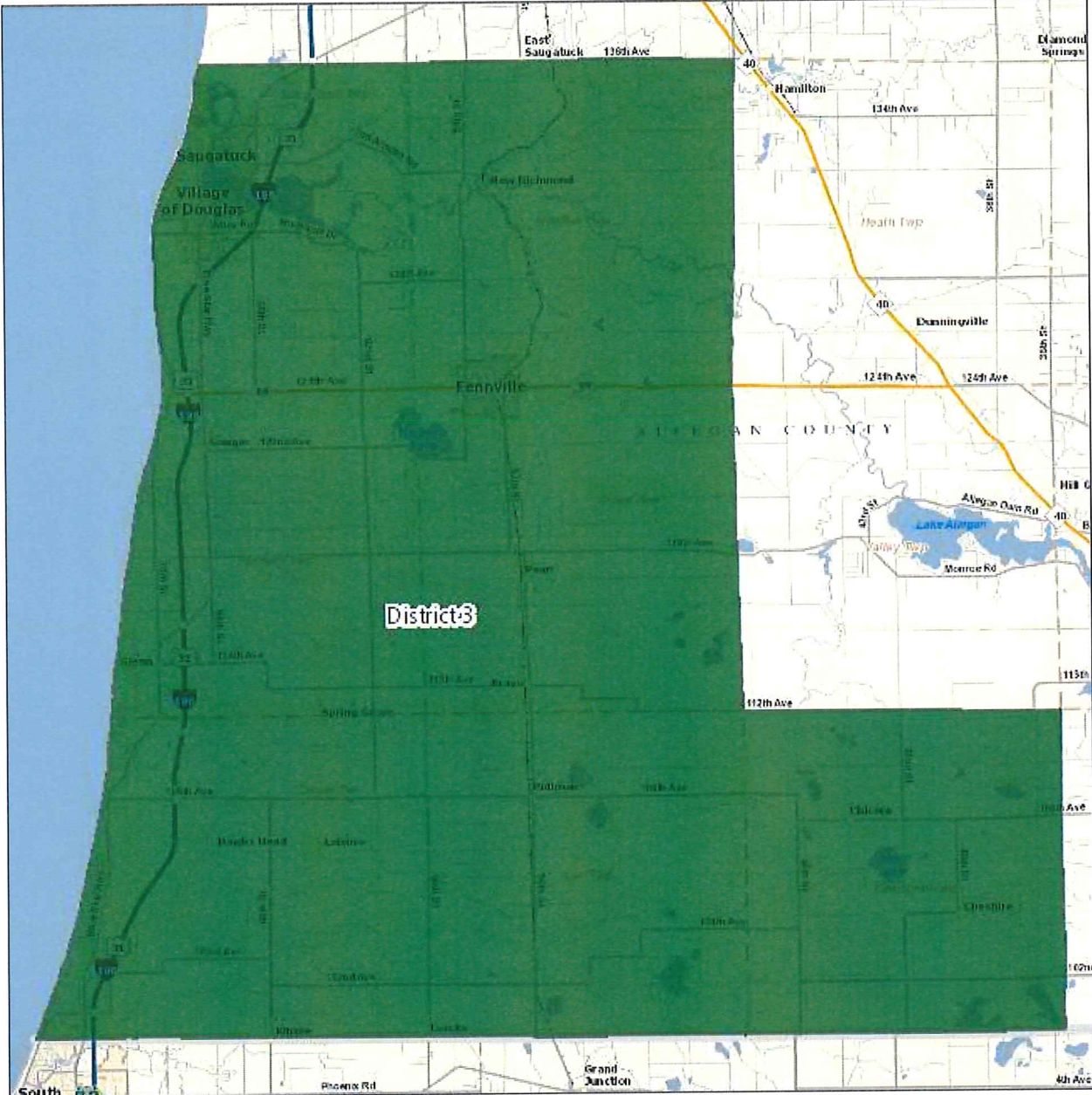
Alleghan County Reapportionment Plan 2021

District 2 - population 22,931



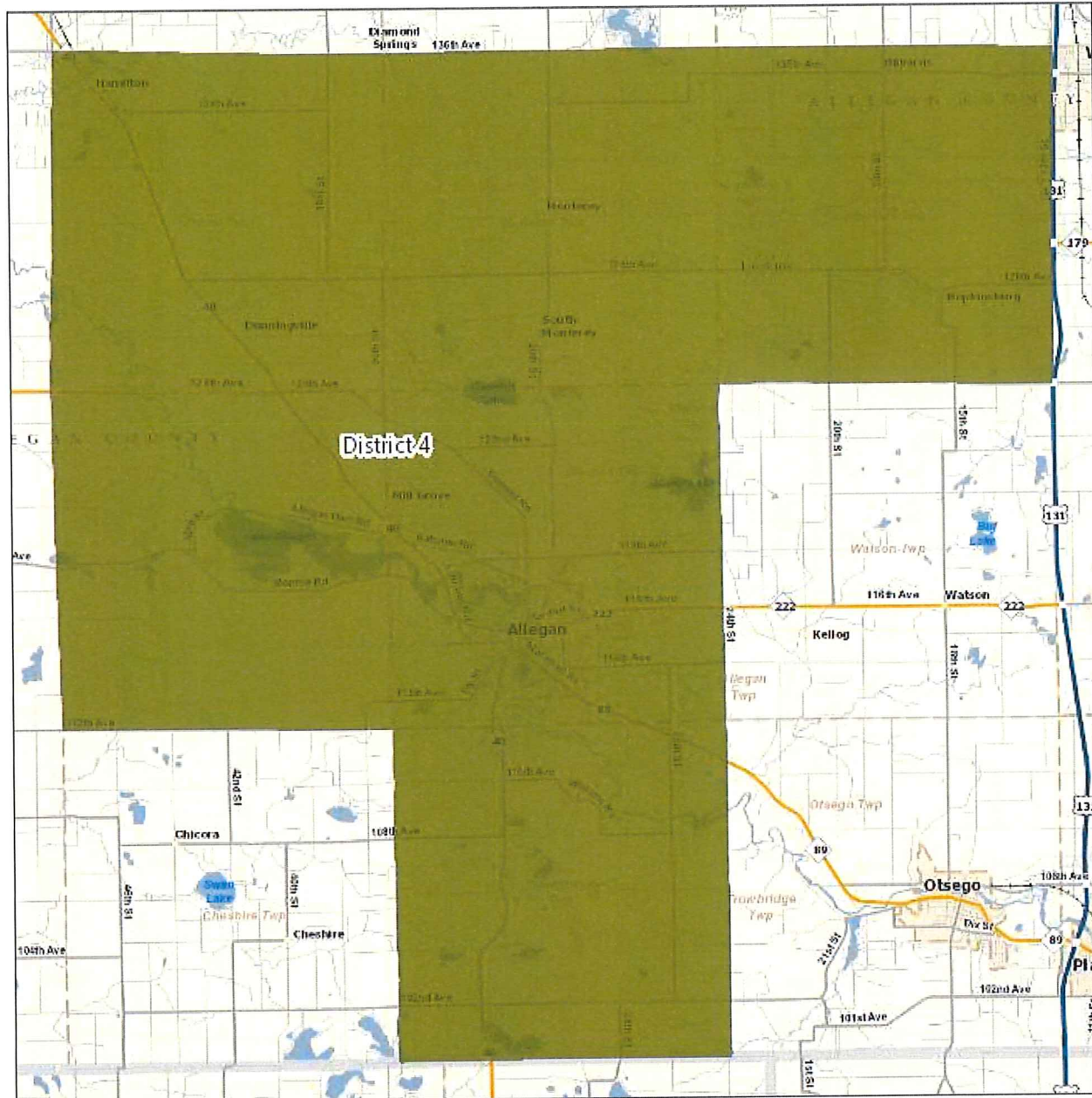

District 3 - population 24,193



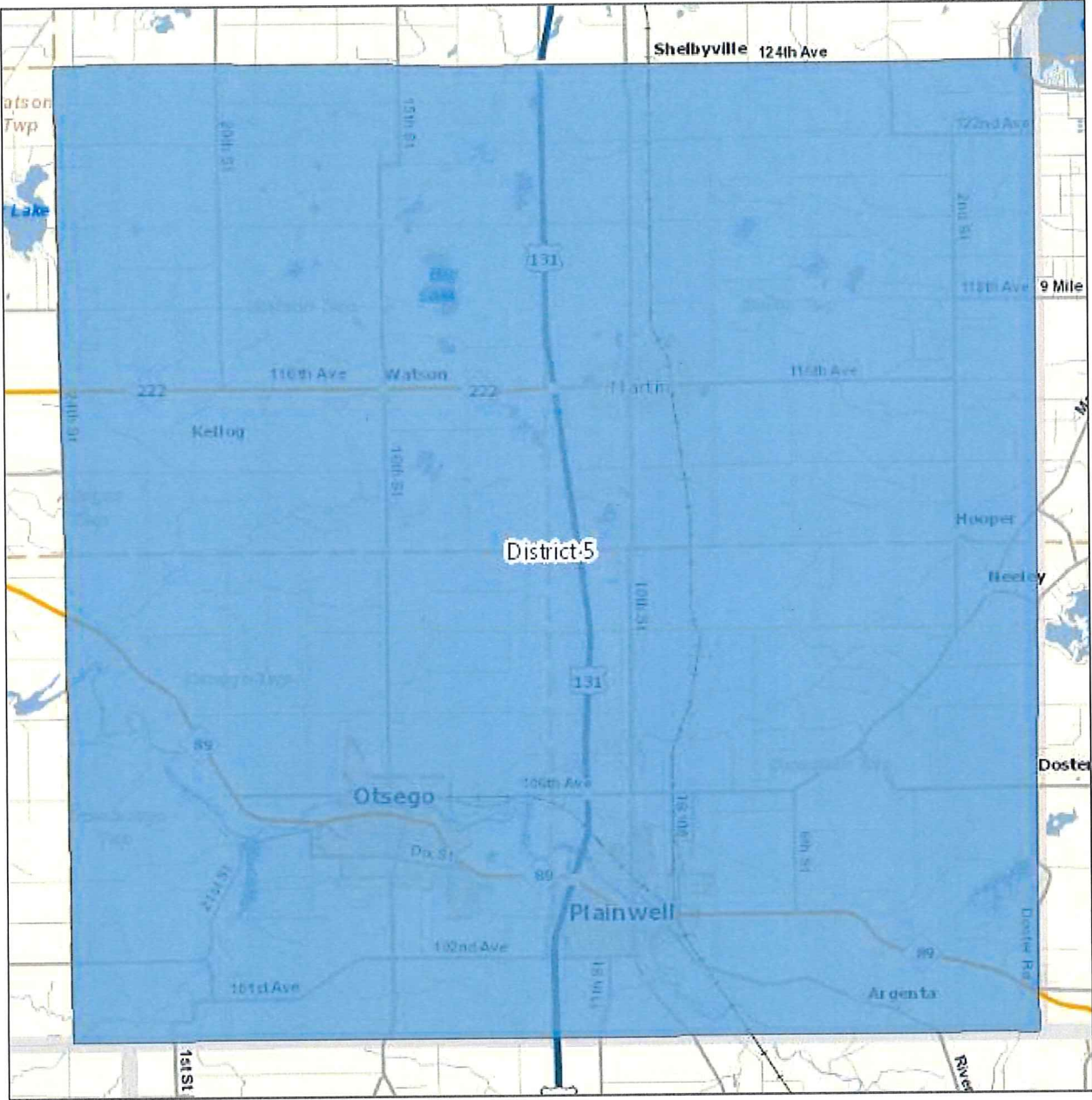
