The undersigned petitioner is Holland Charter Township, County of Ottawa, State of Michigan, and does hereby petition for the maintenance, improvement, and consolidation of the drains known and designated as the Black Creek of Zeeland Intercounty Drain, Black River Improvement Drain of Holland Township, Extension Black Creek of Zeeland Drain, Black Creek of Zeeland Drain Roeloff Branch, Paw Paw Branch to Black River Drain, Zeeland & Holland Black River Drain, Black River Drain, Black Creek Drain, and Black Creek of Zeeland Extension Drain, to be known as the Macatawa River Intercounty Drain, and the consolidation of the Black Creek of Zeeland Intercounty Drain Drainage District, Black River Improvement Drain of Holland Township Drainage District, Extension Black Creek of Zeeland Drain Drainage District, Black Creek of Zeeland Drain Roeloff Branch Drainage District, Paw Paw Branch to Black River Drain Drainage District, Zeeland & Holland Black River Drain Drainage District, Black Creek Drain Drainage District, and Black Creek of Zeeland Extension Drain Drainage District, to be known as the Macatawa River Intercounty Drain Drainage District.

The proposed maintenance, improvement, and consolidation is necessary for the public health, convenience, or welfare and is further necessary for the protection of the public health in Holland Charter Township. Your petitioner further shows that the established drains need consolidating because the drains will be most efficiently maintained as a consolidated drainage system.

Holland Charter Township will be liable for an assessment at-large against it for a percentage of the cost to be assessed for the proposed maintenance, improvement, and consolidation.

WHEREAS, the Township has determined that the maintenance, improvement, and consolidation of the drains and drainage districts is necessary and conducive for the public health in the Township; and

WHEREAS, the Township will be liable for an assessment at large against it for a percentage of the cost of the proposed maintenance, improvement, and consolidation.

NOW, THEREFORE BE IT RESOLVED THAT, pursuant to Chapters 8 and 19 of Public Act 40 of 1956, as amended, a petition for the maintenance, improvement, and consolidation of the Black Creek of Zeeland Intercounty Drain, Black River Improvement Drain of Holland Township, Extension Black Creek of Zeeland Drain, Black Creek of Zeeland Drain Roeloff Branch, Paw Paw Branch to Black River Drain, Zeeland & Holland Black River Drain, Black River Drain, Black Creek Drain, and Black Creek of Zeeland Extension Drain, to be known as the Macatawa River Intercounty Drain, and the consolidation of the Black Creek of Zeeland Intercounty Drain Drainage District, Black River Improvement Drain of Holland Township Drainage District, Extension Black Creek of Zeeland
