#### Kaleigh Dornbush

Kaleigh was recognized by her Supervisor Brian Beute for her handling of a call from a man whose cousin had suddenly gone unresponsive in March. Below is a copy of the recognition letter Brian drafted recognizing Kaleigh's performance.

#### "Kaleigh,

I have the honor today of recognizing you for your exemplary performance on March 24, 2022, answering a call from a man whose cousin had suddenly gone unresponsive. Your caller management, tone, and protocol use on this call was remarkable, saving the man's life.

You quickly entered the call and smoothly navigated the protocol. You clearly recognized the urgent situation and sent the echo call immediately, then initiated patient care.

That leads me to your major contribution to this call—the barriers of the caller and your persistence to treat the patient. You recognized the patient's positioning was dangerous. After understanding and recognizing the caller's concerns, you acknowledged those and gave him reasons and influenced him gradually to help the patient.

Excellent protocol compliance then takes over and "barely" breathing and "turning blue" drove your insistence on giving him the best care. Immediately the patient begins responding and talking, and the only interventions that saved him was your clear instructions.

Throughout, your kind and understanding treatment of the caller showed him respect. You gave early, often reassurance that you would help and your tone was empathetic and very composed, giving him clear instructions and continuing to let him know that help was on the way.

Another big shout-out to the whole team (Brook, Kylie, Brittany) for the assist. Great job Brittany for toning the call within 40 seconds of answering the 911 call. All resources were also updated with changing patient conditions. Thanks for all your service to the citizens and responders of Allegan County.

#### • Lindsey (Hoffman) Lewis

Lindsay was recognized by Sergeant Tyler Gorby of the Allegan City Police Department for her handling of a suicidal call.

"I just wanted to reach out to you and let you know what a great job Lindsey Hoffman did with a suicidal call tonight. She took a call with a male stating he was going to kill himself and had a gun to his chest. He said he wanted us to know so that we found his body and not his kids. While all of us were on scene trying to make contact with the male he fired one round. Thankfully, he only shot a round off into the air and then eventually came out to us. While we were talking to him he stated the reason he didn't shoot himself was because of the dispatcher. He stated the tone of her voice stuck with him after he hung up on her.

I truly believe Lindsey saved a life tonight and wanted to make sure it didn't go unnoticed.

**1. PURPOSE**: To provide a standard for dispatching public safety resources for Emergency Medical incidents as they are reported to Central Dispatch.

2. SERVICE AREA(s) AFFECTED: Allegan County Central Dispatch (ACCD)

#### 3. **DEFINITIONS**:

3.1. **ECHO** – An immediate life threatening medical

#### 4. POLICY:

- 4.1. ACCD shall incorporate and follow an industry recognized Emergency Medical Dispatch (EMD) system for the purpose of providing the most appropriate care and dispatch protocols available.
- 4.2. Telecommunicators shall follow the Official Allegan County Emergency Medical Service (EMS) policy for all emergency medical calls.
- 4.3. Telecommunicators shall not dispatch Law Enforcement Officers (LEO) to medicals prior to Medical First Responders (MFR).
- 4.4. All ECHO calls shall be dispatched according to the official Allegan County ECHO policy/procedure.
- 4.5. This policy supersedes all previous policies related to EMD or where conflict appears.
- 4.6. The procedures below have been developed to provide as much notice as possible to the appropriate emergency medical responders when there is an emergency medical incident to ensure expedient response times while also providing as accurate information as can be procured from the caller, or other resources available to the Telecommunicator, to include but not limited to Personal Injury (PI) accidents and Unknown accidents.

#### 4.6.1. Unknown Accidents

4.6.1.1. Property Damage Accident (PDA): In the case of a reported PDA the law enforcement dispatcher shall do an open broadcast alerting LEOs and MFRs of

- the incident using 03P911, 03F911E and 03F911W. There shall be no acknowledgement of this open broadcast back to Dispatch.
- 4.6.1.2. If it is determined that the PDA incident has transitioned to a Personal Injury (PI) incident dispatch shall page the appropriate MFR agency as soon as a priority for the call is determined.
- 4.6.1.3. If it determined there are no injuries and the incident is confirmed as being a PDA only a second open broadcast will be made on 03F911E and 03F911W notifying MFRs of such.
- 4.6.1.4. Central Dispatch will not do an open broadcast for Vehicles In the Ditch (VID), Slide Offs, or if the call is automatically reported as a PDA at the time of call.

#### 4.6.2. Medicals

- 4.6.2.1. Upon receiving a 911 medical call EMD case entry will commence and the call taker shall assign the appropriate MFR agency to the call for service prompting a "Rip & Run" or "Active 911" notification from CAD to the agency, pre-alerting them of the impending dispatch.
- 4.6.2.2. Once dispatch determines a priority for the call the appropriate MFR/EMS agency will be paged/dispatched.
- 4.6.2.3. If at any time after per-notification or dispatch a scene is determined unsafe the appropriate agencies shall be notified via radio to stand down and/or stage until the scene is safe.

 ${\tt WHEREAS}$ , on May 4, 2022, the Committee met with Dr. Mastenbrook and Dr. Walters; and

WHEREAS, at a follow-up meeting held on June 16, 2022, a draft policy and workflow were presented and refined by the committee; and

WHEREAS, Greg Janik, the President of the Fire Chief's Association was present and provided input and representation of support of the Fire Chiefs of Allegan County towards the adoption of the Emergency Medical Dispatch Policy (Pilot Policy); and

WHEREAS, the Pilot Policy was unanimously voted by the Committee to be recommended for adoption by the Board as a pilot for a specific period of review.

THEREFORE BE IT RESOLVED, the Board hereby adopts and approves the attached Pilot Policy; and

**BE IT FURTHER RESOLVED** the Pilot Policy shall be in effect August 1, 2022 - October 18, 2022; and

BE IT FURTHER RESOLVED any comments or feedback relative to the Pilot Policy shall be submitted to Central Dispatch using "TrackIt" and shall be compiled by the Dispatch Director and shared with the 911 Policy & Procedure Board on October 18, 2022, for review; and

BE IT FURTHER RESOLVED the 911 Policy & Procedure Board shall use the comments and feedback compiled in determining the permanence of the Pilot Policy and/or any changes that may need to be implemented; and

BE IT FINALLY RESOLVED the Central Dispatch Director is instructed to communicate the details of the Pilot Policy to all Central Dispatch Personnel, and Allegan County Fire Departments including a copy of this resolution with the intent of starting the Pilot Policy on August 1, 2022.
