PRESENTATION: Julie Hulsey – WaterTrail Ventures LLC spoke of kayaking the Kalamazoo River. WaterTrail Ventures LLC has been in operation for 5 years and they operate below the dam from Allegan Dam to Saugatuck Township. They provide kayaking for all skill levels. This summer has been a busy year and business continues to grow each year. They lead kayakers through areas of the river which pass hiking trails. Julie stated these hiking trails need attention, especially aroura Swan Creek and Ely. These trails have become overgrown and have little to no signage. Promoting a maintained trail system would bring even more tourists and kayakers to these areas of the river. Albright suggested their group get in touch with Don Poppy at the DNR office and he could help them get in touch with past volunteers. Albright also stated there is no

a. Walking/Hiking

• Gildea stated that we have requested quotes for large Z-Cards to potentially use for maps of different types of trails. The quote for 10,000 of these cards is \$6,995. The cost could go up or down with how many are produced.

b. Winery/Brewery

• Gildea states that a list should be developed of the Wineries and Breweries in Allegan County now that they are established. The Heritage Trail will be changing and the list could be attached to this.

c. ORV

- Gildea has reservations on creating maps with current ORV roads as they are always changing.
- Beltman agrees it would be a good idea to wait on maps because by next spring, all roads may be added to the ORV system.

d. Other

• Burn suggested a tourism website with a search function that can pull Allegan county activities by date of visit. Gildea stats that we do not have the time/staff/ nor feedback to keep this type of information updated.
